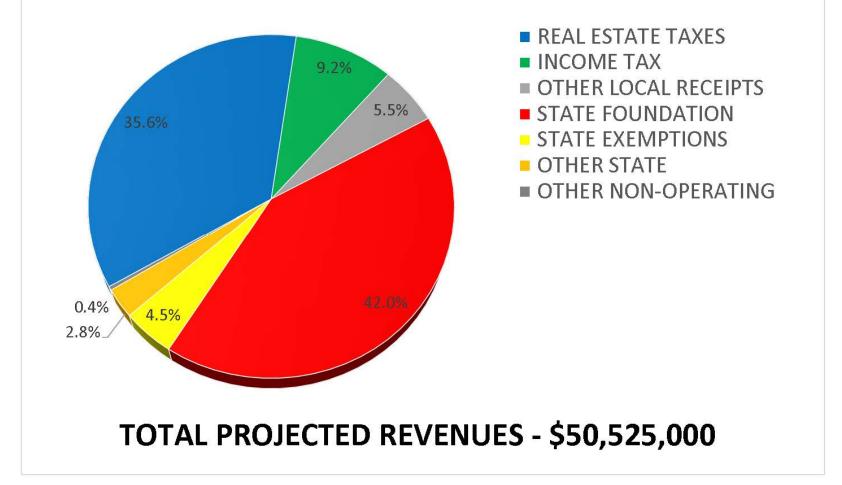

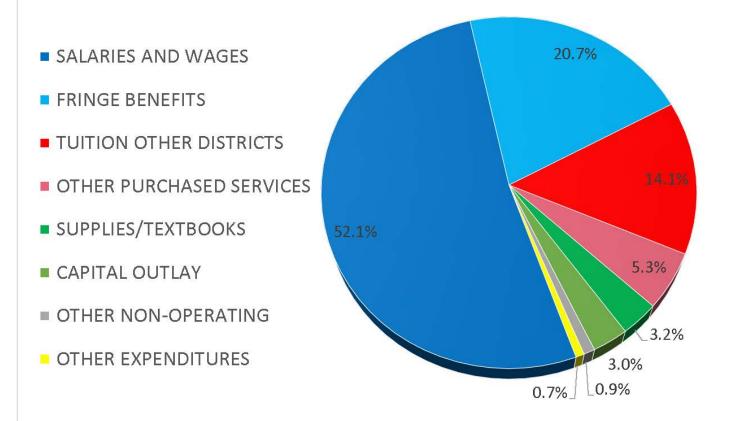

PROJECTED FY 2022 REVENUES FAIRBORN CITY SCHOOLS, 7/1/21 - 6/30/22



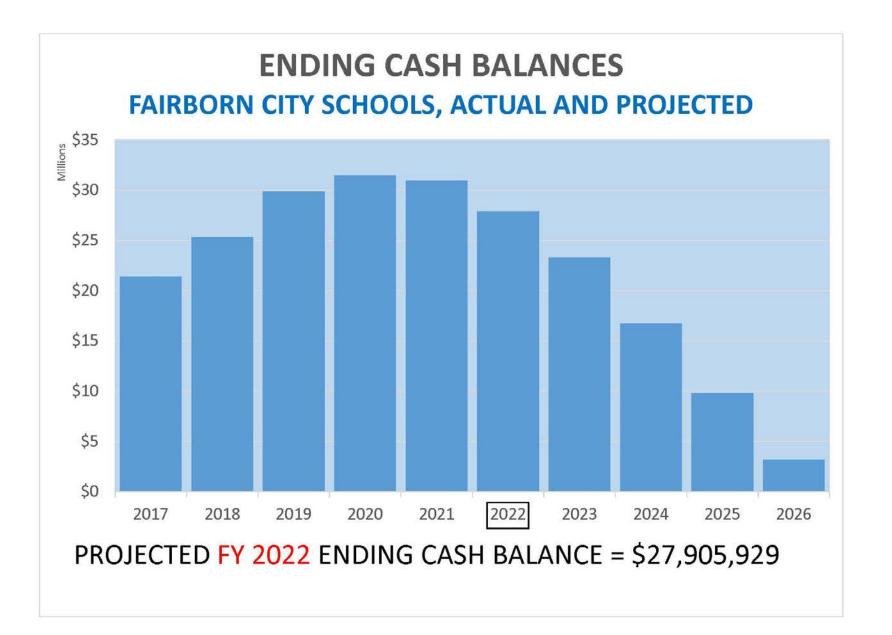
PROJECTED FY 2022 EXPENDITURES FAIRBORN CITY SCHOOLS, 7/1/21 - 6/30/22

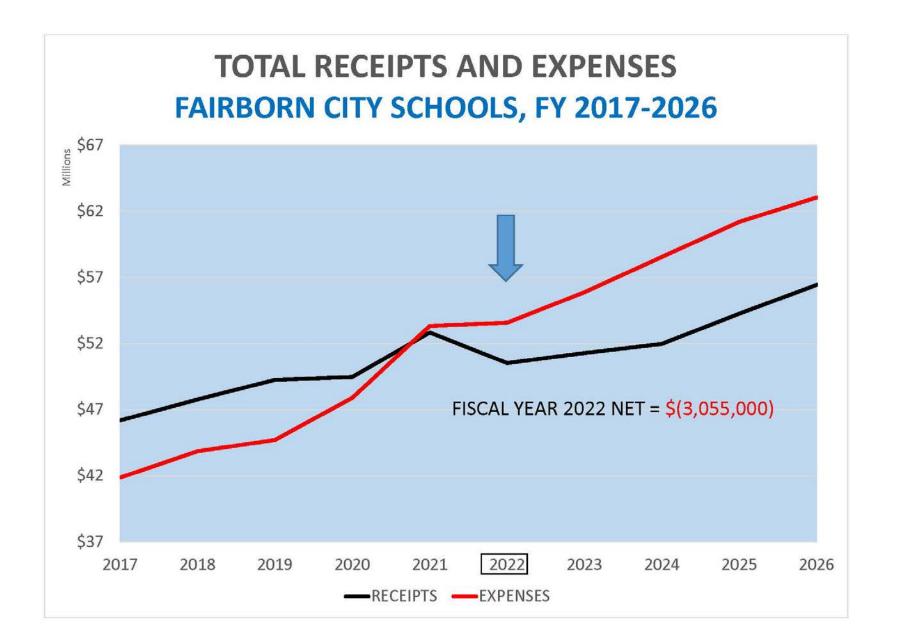


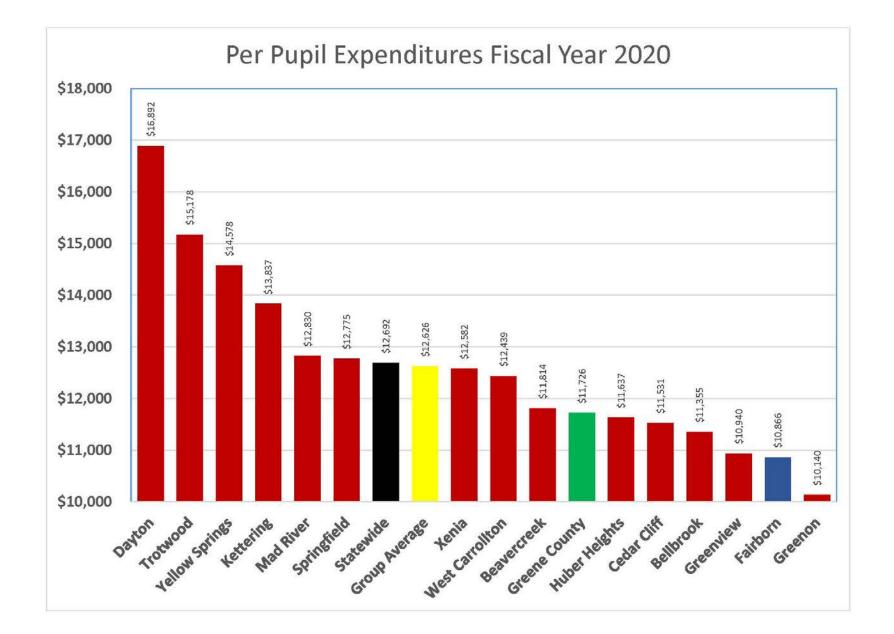

ENDING CASH BALANCE HIGHLIGHTS

- CASH BALANCES PEAKED AT THE END OF FISCAL YEAR 2020 AND THEN DROPPED SLIGHTLY IN FISCAL YEAR 2021.
- CASH BALANCES DRAMATICALLY DECREASE IN FISCAL YEARS 2023, 2024, AND 2025 WHEN EXPENDITURES ARE PROJECTED TO EXCEED REVENUES. THIS INDICATES THE POSSIBLE NEED FOR A NEW OPERATING LEVY TO BE PASSED IN CALENDAR YEAR 2024.
- PROJECTED FIVE YEARS OF FINANCIAL STABILITY DEPENDING ON VARIABLES. (VERY DIFFICULT IN THE STATE OF OHIO WITH CURRENT FUNDING SYSTEM)
